## CHILD SERVICES

### PSYCHOEDUCATIONAL ASSESSMENTS

Thank you for your interest in receiving behavioral health services from Perez & Associates, LLC (PALLC). For a general understanding of our process, please review this document prior to scheduling your child's first appointment. We are more than happy to answer any questions you may have and look forward to working with your family.

#### **PSYCHOEDUCATIONAL ASSESSMENTS**

Psychoeducational assessments consist of three components- Initial Interview, Testing Session, and Feedback Session. Each service is billed independently.

During the 50-minute Initial Interview, we will discuss your concerns and determine the appropriate measures to assess your child's personal strengths and weakness. The Initial Interview fee is due at this visit. If the evaluation occurs during the school term, your child's teacher(s) may be asked to complete a version as well. These behavior scales will give us more information about your child's mood and behavior. A deposit, half the testing fee, is due at the time of scheduling to secure your requested date and time.

The Testing Session is typically completed within approximately 3-4 hours depending on your child's symptoms, cooperation, and attention level. Although most assessments are completed within one day, an additional day of testing may be needed if your child has difficulty completing the evaluation with the allotted breaks. If an additional day of testing is needed, there is no additional fee as long as the total assessment is completed within 3-4 hours. Occasionally, a graduate-level clinician may assist with the test administration and scoring under the supervision of our psychologist.

Psychoeducational reports are typically completed within 3-5 weeks of your child's testing appointment. All test results and recommendations will be discussed during a 50-minute Feedback Session. You and your child will have the opportunity to ask questions and determine if you would like the report shared with your child's school or an outside agency.

## **PAYMENTS**

PALLC does not accept insurance. If you wish to be reimbursed for sessions, it is highly recommended you consult with your insurance company prior to scheduling treatment. Payment is due at the time of service. All major credit cards are accepted. Although PALLC will not file insurance claims on your behalf, you will be provided with the information needed (date of service, CPT code and diagnosis) for reimbursement from your insurance company.

## **CANCELLATIONS AND NO-SHOWS**

If you must cancel or reschedule your testing appointment, a five (5) business day notice is required. If your testing appointment is cancelled with less than a five business day notice or if you fail to present for a testing session, you will forgo your testing deposit.
